OPĆI UVJETI

1. OPĆE ODREDBE

Pravne i fizičke osobe iz Republike Hrvatske i inozemstva koje uredno i pravodobno ispune prijavu za izložbeni prostor što ujedno predstavlja i ugovor o izlagačkom prostoru (dalje i: Izlagači) i/ili se registriraju kao Posjetitelji (dalje i: Posjetitelji), a oboje dalje u tekstu i kao: „Sudionici“, imaju pravo sudjelovati na Croatia Charter Expo 2021 (dalje: CCE). Podnošenjem popunjene prijave Sudionici potvrđuju svoje sudjelovanje na CCE-u i prihvaćaju sve uvjete i cijene onako kako ih je odredio organizator. Krajnji datum za predaju prijave/ugovora organizatoru je 10. rujna 2021. Organizator zadržava pravo odlučivanja o prihvatu svake pojedinačne prijave te će Sudionike obavijestiti o eventualnom odbijanju prijave u roku od 10 dana od primitka iste.

2. PRIJAVE I PLAĆANJE

Prijava/ugovor je neopoziv i obvezujući za sve Sudionike. Sve prijave za sudjelovanje na CCE-u odnose se samo na Izlagače i Posjetitelje koji su ovlašteni od Organizatora na sudjelovanje. 3. PROSTOR ZA IZLAGAČE I DODATNE USLUGE

Izlagač se obvezuje da će sve eksponate donijeti najmanje 18 sati prije otvaranja CCE-a. Ako izlagač iz bilo kojeg razloga ne može poštovati navedeni rok od 18 sati, izlagač može zatražiti od organizatora pismeno odobrenje za produljenje roka, a organizator će donijeti odluku i obavijestiti izlagača. Ako izlagač izmijeni dodijeljeni prostor, mora biti u skladu s primjenjivim standardima i pravilima tehničke zaštite. Izlagači i posjetitelji sajamske izložbe moraju se pridržavati odredbi Kućnog reda Marine Kornati, koji je sastavni dio ovih Općih uvjeta. Nakon završetka CCE-a, izlagač će napustiti izložbeni prostor i vratiti dodatnu opremu u stanju u kojem ju je primio. TERMS AND CONDITIONS

1. GENERAL PROVISIONS

Legal and natural persons from the Republic of Croatia and abroad who duly and timely fill in the application for exhibition space, which also represents the contract on exhibition space (hereinafter: Exhibitors) and / or register as Visitors (hereinafter: Visitors), and both further in text and as "Participants", have the right to participate in Croatia Charter Expo 2021 (hereinafter: CCE). By submitting a completed application, Participants confirm their participation in the CCE and accept all conditions and prices as determined by the organizer. The deadline for submitting the application / contract to the organizer is September 10, 2021. The organizer reserves the right to decide on the acceptance of each individual application and will notify the Participants of any rejection of the application within 10 days of receipt.

2. APPLICATIONS AND PAYMENT

The application / contract is irrevocable and binding on all Participants. All applications for participation in the CCE relate only to Exhibitors and Visitors authorized by the Organizer to participate. Exhibitors are not authorized to sublet the allocated exhibition space to another natural or legal person, and if they do, it will result in an exemption from participation in the CCE, in which case the Organizer has the right to charge a double participation fee. In the exhibition space, exhibitors can exhibit only their own products or those that they have the right to promote as authorized distributors. In addition, exhibitors may exhibit only the equipment and services indicated in the application for space, consistently adhering to the provisions of the application / contract, with the obligation to submit to the organizer for approval a list of services they intend to provide and products they intend to exhibit no later than 14 days before the event. If the application / contract of the exhibitor and / or visitor is accepted, the organizer sends a detailed offer with the total price and payment information.

The Exhibitor is obliged to pay a minimum of 50% of the amount no later than August 01, 2021 and the remaining 50% no later than September 30, 2021, while Visitors are required to pay the full amount in advance, immediately upon receipt of the invoice.

3. SPACE AND ADDITIONAL SERVICES

The Organizer undertakes to provide Exhibitors with access to the exhibition space and the ordered equipment no later than 24 hours before the opening of the exhibition. The Exhibitor undertakes to bring all exhibits at least 18 hours before the opening of the CCE. If the Exhibitor for any reason cannot meet the stated deadline of 18 hours, the Exhibitor may request written approval from the Organizer to extend the deadline, and the Organizer will make a decision and inform the exhibitor. If the exhibitor changes the allocated space, it must comply with the applicable standards and rules of technical protection. Exhibitors and Visitors of the fair exhibition must comply with the provisions of the House Rules of Marina Kornati, which is an integral part of these General Terms and Conditions. Upon completion of the CCE, the exhibitor will leave the showroom and return the accessories in the condition in which they were received. Any damage to the exhibition space and equipment will be settled by the Exhibitor. The Application / Contract applies only to the Exhibitor and the company that is registered and authorized by the Organizer to participate. The Exhibitor may display and exhibit products and services that they are officially authorized to represent. Failure to provide proof of authorization of representation may result in said products or services being banned from exhibition by the Organizer. The Exhibitor may not assign space in the show to another company without the Organizer's approval.

4. SALE AT THE SHOW SITE

The Exhibitor undertakes to sell the products marked in the Application / Contract for participation in accordance with the regulations and legislation standards of the Republic of Croatia and the European Union. For any product that does not comply, the Exhibitor must issue a written notice to the CCE Visitor.

5. OPENING HOURS

The CCE is open to visitors on Thursday, 21.10.2021 from 12:00 to 19:00, and on Friday, 22.10. 2021 from 10:00 to 18:00 in HALL D.

Biograd Boat Show je otvoren za posjetitelje od 20. do 23.10.2021 od 10:00-18:30 h i u nedjelju 24.10.2021 od 10:00 do 18:00h. Izlaganje ne može biti uklonjeno sa sajma tijekom njegovog trajanja te izlagač ne smije ni u kojem trenutku ostaviti izložbeni materijal bez nadzora.

The Biograd Boat Show is open to CCE Participants from 20 to 23.10.2021 from 10:00 - 18: 30 h and on Sunday 24.10.2021 from 10:00 to 18:00 h. No exhibit may be removed from the show during its duration and the Exhibitor must not at any time leave the exhibition material unattended.

6. ODGOVORNOST I OSIGURANJE

Organizator nije odgovoran za bilo kakvo oštećenje ili gubitak opreme i drugih eksponata te osobnih stvari. Izlagač će biti odgovoran za štetu nanesenu organizatoru ili trećoj strani korištenjem ili posjedovanjem eksponata od drugih izlagača. Izlagač je obavezan osigurati sadržaj njegove izložbe kod osiguravajućeg društva.

6. LIABILITY AND INSURANCE

The Organizer is not responsible for any damage or loss of equipment and other exhibits and personal belongings. The Exhibitor will be liable for damage caused to the organizer or a third party by the use or possession of exhibits by other exhibitors. The exhibitor is obliged to insure the contents of its exhibit with the insurance company.

7. OTKAZIVANJE UČEŠĆA

Ako Sudionici (Izlagači ili Posjetitelji) podnesu Organizatoru pisani otkaz svoje prijave 45 ili manje dana do predviđenog dana otvaranja CCE-a, ugovorne strane su suglasne kako su Sudionici u takvim slučajevima obavezni platiti Organizatoru 100% iznosa cijene navedene u prijavi/ugovoru. Ako Sudionici zatraže povlačenje prijave i otkaz sudjelovanja u roku od 45 ili više dana do predviđenog dana otvaranja CCE-a, ugovorne strane su suglasne kako su Sudionici u tom slučaju obavezni platiti Organizatoru 50% fakturiranog iznosa navedenog u prijavi/ugovoru za Sudionike.

7. CANCELLATION OF PARTICIPATION

If the Participants (Exhibitors or Visitors) submit a written cancellation of their application to the Organizer 45 or less days before the scheduled opening date of the CCE, the parties agree that the Participants in such cases are obliged to pay the Organizer 100% of the price stated in the application / contract. If the Participants request the withdrawal of the application and cancellation of participation within 45 or more days until the scheduled opening day of the CCE, the parties agree that the Participants are obliged to pay the Organizer 50% of the invoiced amount specified in the application / contract for Participants.

8. OTKAZIVANJE DOGAĐANJA

Organizator je dužan izlagaču isporučiti ugovorene usluge na događaju. Ako organizator nije u mogućnosti održati događaj zbog njegovog otkazivanja, organizator će Sudionicima vratiti 100% uplaćenih sredstava na njihov račun. Sudionici nemaju pravo tražiti naknadu za dodatne troškove ili štetu koja bi mogla nastati zbog otkazivanja događaja niti je Organizator u obvezi je naknaditi.

8. CANCELLATION OF THE EVENT

The Organizer is obliged to deliver the contracted services to the exhibitor at the event. If the Organizer is unable to deliver the event due to its cancellation, the Organizer will refund 100% of the funds received to the Participant's account. Participants are not entitled to claim compensation for additional costs or damages that may arise due to the cancellation of the event nor is the Organizer obliged to reimburse it.

9. AKREDITACIJA – PROPUSNICA ZA CCE

Pravila o davanju i korištenju akreditacije određuje organizator, te o tome pravovremeno informira Sudionike. Propusnica za Sudionike CCE izdaje se osobi koja je akreditirana od strane izlagača/posjetitelja i samo je ta osoba ovlaštena za korištenje propusnice. Sudionici CCE-a imaju pravo pristupa Biograd Boat Showu. Sudionici će ispuniti zahtjev za akreditaciju i vratiti organizatoru obrazac najkasnije do 1. listopada 2021. U slučaju kašnjenja u podnošenju obrasca zahtjeva za akreditaciju, organizator zadržava pravo da ih naplati prema važećem cjeniku. U slučaju zlouporabe akreditacije, organizator može odbiti pružanje usluga a osoba koja koristi tuđu akreditaciju bit će udaljena sa događaja.

9. ACCREDITATION - CCE ENTRY PASS

The rules on granting and using accreditation passes are determined by the Organizer, and the Participants are informed about it in a timely manner. A pass for CCE Participants is issued to a person accredited by the Participant, and only that person is authorized to use the pass. CCE Participants will also have full access to the Biograd Boat Show. Participants will fill out an accreditation request and return the form to the Organizer no later than October 1, 2021. In case of delay in submitting the accreditation request form, the Organizer reserves the right to charge them according to the valid CCE Price List. In case of misuse of accreditation, the Organizer may refuse to provide services and the person using someone else's accreditation will be removed from the event.

10. FOTOGRAFIJE, AUDIO I VIDEO ZAPISI I OGLASNI MATERIJALI

Tijekom događaja organizator može fotografirati i snimati audio i video zapise u izložbenim prostorima te koristiti snimljeni materijal u svoje i opće svrhe. Sudionici se odriču autorskih prava i prava na takve materijale te ne smiju snimati snimke bez odobrenja organizatora, osim u svom izložbenom prostoru. Izlagači mogu posjetiteljima ponuditi reklamni materijal samo u dodijeljenom izložbenom prostoru; u suprotnom organizator će konfiscirati i ukloniti sve tiskane i reklamne materijale koji su pronađeni izvan izložbenog prostora izlagača.

10. PHOTOS, AUDIO AND VIDEO RECORDINGS AND ADVERTISING MATERIAL

During the event, the organizer can take photos and make audio and video recordings in the exhibit spaces and use the recorded material for their own and general purposes. Participants waive copyright and rights to such materials and are not allowed to make recordings without the Organizer's approval, except in their own exhibition space. Exhibitors may offer visitors promotional material only in the allotted exhibition space; otherwise the Organizer will confiscate and remove all printed and advertising materials found outside the Exhibitor's exhibition space.

11. ZAVRŠNE ODREDBE

Ovi Opći uvjeti sastavljeni su na hrvatskom i engleskom jeziku, a u slučaju spora, dvojbe oko tumačenja ili primjene pojedinih njegovih odredbi, mjerodavna je verzija napisana na hrvatskom jeziku.

11. CLOSING PROVISIONS

The terms and conditions of this Application/Contract are provided in English and Croatian, and with the Croatian version being binding for legal disputes under Croatian Law.

U slučaju spora koji proizlaze iz kršenja ili pogrešne interpretacije odredbi Općih uvjeta, prijave/ugovora, obrasca prijave i sl., organizator i Sudionici međusobno su suglasni s nadležnošću Trgovačkog suda u Zadru. Mjerodavno je pravo Republike Hrvatske.

In the event of a dispute arising from this Application/Contract the Organizer and Exhibitor mutually agree the legal jurisdiction for solving any dispute is the Commercial Court in Zadar, Croatia.
